Section II: General Correspondence:

Investments:

FY/16 Appropriation Distribution-Tony Tranghese from FIA recommended no change from previously approved distribution schedule. Mr. Tranghese told the Board the paperwork to complete the approved distribution will be sent and completed on time.

Investment Performance Review-Mr. Tranghese gave the Board a copy of the Chapter 68 performance comparison as of December 31, 2014. Mr. Tranghese made note that it is important to focus on the 10 year performance when considering Chapter 68 Law and the potential of having to transfer retirement board assets to the PRIT Fund. Mr. Tranghese informed the Board that the 10-year annualized return as of 12/31/14, for Plymouth is 6.78% and PRIM is 7.01%, a difference of - .23%. Mr. Tranghese added, while looking at the rolling ten year annualized performance difference, it is clear as difficult years roll off, the ten –year annualized performance gap closes. Plymouth would need to underperform by 12%-14% to be concerned.

Mr. Duhamel asked Mr. Tranghese if there are any Systems running in the danger zone.

Mr. Tranghese answered that the Boards that have underperformed by at least 2 percentage points are already in PRIT.

Atty. Sacco mentioned that the Southbridge Retirement System was forced into PRIT but there are many Boards under 65% funded.

Mr. Duhamel mentioned that the Leominster Retirement System has not voted a COLA in six years and their earnings assumption has been dropped to 4.5%. By keeping the assumption rate too low, a burden is put on the tax payers. He added that 48 Systems are still at the \$12,000.00 COLA base.

Mr. Tranghese told the Board that the total fund as of April 30, 2015, was at \$145,735,215. This is up 1% for both the Month and Quarter and up 3.8% YTD. The May 2015 numbers just came out and will be available next month.

The Board thanked Mr. Tranghese.
